APPOINTMENT OF TWO NEW INDEPENDENT NON-EXECUTIVE DIRECTORS

Robert is currently a director of Multiple Sclerosis Society Ltd, Australian Home Care Services Pty Ltd and Stillwell Motor Group. Robert is also chair of EV Engineering Ltd and chair of the Advisory Board, Department of Management at Monash University.
